Workshop content

Dr. Wolf Wolfensberger of the Training Institute developed this workshop in order to equip people with the special combination of worldviews, preparation & support they will need in order to survive with high moral ideals, with integrity intact & hopefully also with some effectiveness in human services, especially when services, & the larger society in which services function, are not working well. Some of the assumptions underlying the content of this workshop are:

- there are powerful dynamics of disfunctionality in the world;
- these dynamics express themselves in derivative disfunctionalities in society, as well as in human service approaches, systems & structures;
- though most people are not, or do not want to be, aware of these dynamics, it is imperative that people who want to function with greater moral coherency become aware of them;
- many of these dynamics can be known & understood, & once a person is aware of these dynamics, then one can respond much more adaptively in the world;
- there exists an array of adaptive strategies for living with these harsh realities;
- many of these adaptive strategies can be taught & learned, & a person who learns & applies them can function with greater moral coherency in human services & the larger society.

This workshop is **not** intended to provide participants with specific solutions to specific problems. Instead, participants will learn an array of universally-applicable strategies that they can then apply to whatever situations confront them. Even in a workshop of this length, many of the strategies can only be covered in enough depth to delineate the essentials, to awaken consciousness, to enable participants to identify adaptive strategies themselves & to point participants toward further study & progress in these various strategies. A great many handouts will be distributed, including ones that point to further resources on various of the topics.

Workshop teachers

The presenters are a group of Training Institute staff & associates who have been studying the topic & workshop materials over a period of years, initially under the instruction & direction, & with the collaboration of, the late Wolf Wolfensberger, past director of the Training Institute.

Workshop format

The format of this event is lecture style. A series of presentations will be given, each one on a separate topic in the unfolding sequence of topics. Some of these presentations are quite lengthy, e.g., several hours long. Following each presentation there is ample opportunity for participant comment & general discussion. This means that participants must be prepared to attend closely to a presentation, often for a long period of time, & make notes to themselves on points they want to discuss, or do not understand or agree with, as the presentation goes along. Further information on format will be sent with confirmation of registration.

Fees

- **Tuition** fee \$950 US funds per person, which includes meals (three meals a day for the first six days, two meals on the last day of the workshop).
 - * This fee does **not** include overnight accommodations (please see below).

- **Accommodation** fee for seven nights at the university: \$250 USD
 - * Each room contains a single bed, desk & chair. There is a common bathroom & shower area.
 - * Participants may arrive the evening of June 1 & must check out of their rooms on the last day of the workshop (June 8) **unless** they make prior arrangements & pay an additional fee for an extra night (cost for extra nights is \$30 per night).
 - * Alternatively, nearby hotel information will be included with confirmation of registration.

⇒ **Total** cost of tuition plus on-campus room & board is \$1200 USD for the entire workshop. This amount includes the workshop fee, staying overnight & meals for seven days.←
